## Northallerton Homegrown Food Festival 2024: Trading Terms and Conditions

## **Public Liability Insurance**

- 1.1. Stallholders/traders are responsible for the insurance of their own property and must have current Public Liability Insurance to the value of £2 million at the time of the event.
- 1.2. The stallholder or agents shall not hold the organisers responsible for any loss, damage, theft or destruction of any exhibit, goods, property or equipment.

#### Health & Safety/Food Safety

- 1.3. Stallholders/traders selling food must be registered with the Local Authority and be included in the National Food Hygiene Rating Scheme and have a Food Hygiene Rating Score of 3 or above. Stallholders/traders who have not been inspected by local authority enforcement officers will not be allowed on site.
- 1.4. Stallholders/traders must comply with relevant food hygiene regulations with regards to the preparation/storage/packaging and transportation of produce.
- 1.5. Sites may be inspected by Environmental Health, Trading Standards Officers or any other professional body.
- 1.6. If your stall requires any powered appliances, you must supply the relevant safety certificates; you must also provide your own fire extinguishers and must provide barriers around this equipment.
- 1.7. Stallholders/traders selling food must have food hygiene certificates Level 2.
- 1.8. Stallholders using liquid gas petroleum cylinders are expected to provide suitable storage facilities. All cylinders must be installed prior to the opening of the event and must not be transported during the event.

#### General

- 1.9. Stalls/pitches/plots are non-transferable.
- 1.10. The event is officially open at the following hours: 10am to 5pm. Stallholders are required to be set up by 9.30am and stay for the full duration of the event. You may only begin packing up after 5pm. Failure to adhere to this may mean you will not be allowed to trade at future events.
- 1.11. Anyone found selling illegal, counterfeit or inappropriate goods will be removed from site and the relevant authorities informed.
- 1.13. Refunds will not be given.
- 1.14. The organisers of the Homegrown Food Festival reserve the right to cancel this agreement at any time by giving notice in writing to the stallholder at the address given on the booking form whenever it is of the opinion that the continuance of the hiring would not be in the interests of the good management of the site or in the event of the Government, the Council or other Public Body requiring the use of the site for any matter of special importance.
- 1.15. Please note that priority will be given to stallholders from within a 40 mile radius of Northallerton.
- 1.16. Your stall must be kept tidy at all times and your all trade rubbish removed at the end of the event. Failure to do so may mean you will not be allowed to trade at future events.
- 1.17 The Homegrown Food Festival does not allow the use of ANY polystyrene packaging for the sale of food products.
